Newman House construction will radically change lives

Few causes are as significant as preventing and decreasing trauma in a young life. Child abuse, minors living in homelessness, runaway youth and young adults aging out of foster care who are immediately unsheltered are growing issues and Advocates is committed to addressing them.

Advocates stands out as the sole agency in northwest Georgia providing dedicated housing for youth but must address the urgent and escalating issue of rural youth homelessness.

Advocates' exciting upcoming project, Newman House, is poised to address this concern comprehensively. Serving as a drop-in center for runaway and homeless youth ages 14-24, the facility will also provide emergency housing for children ages 6–17 and long-term housing for young adults ages 14-24 experiencing homelessness. Many of these teens and young adults are enduring tremendous hardships.

Construction began in May with the goal of opening Newman House to children and families in early 2025. The facility is named for Nancy Newman, co-founder, and her husband John to honor their original vision of housing children at Flowering Branch Children's Shelter more than 40 years ago. Their meaningful legacy will provide efficiency apartments with kitchenettes, bathrooms, shared living areas, a computer lab, a laundry room, a game room and more.

Program Spotlight:

RISE Youth Housing

The Advocates for Children RISE Program is devoted to serving youth experiencing homelessness with little to no income. Most often coming from disadvantaged backgrounds, many have fled challenging family situations or aged out of the foster care system (about 20% of youth in foster care become homeless the moment they turn 18).

Rural youth homelessness is particularly hidden, a fact well documented in most of the 11-county area served by Advocates for Children. Only 23% of rural youth are housed in shelters (versus 50% of youth in larger communities). In northwest Georgia, these "invisible teens" have limited access to support services and often go unnoticed without completing their education or gaining valuable life skills for adulthood.

To compound the problem, unhoused youth are vulnerable to substance abuse, sex trafficking and early pregnancy. In fact, many of our youth clients have already become parents themselves, a responsibility they are unprepared for on so many levels. This year, the population we now serve is forecasted to increase to 80 young adults ages 18-24, their 80 young children and 20 unaccompanied runaway or foster youth ages 6-17.

"The term RISE comes from Resilience, Independence, Success and Empowerment," according to RISE Director Kate Tettamant. "This term represents our hope that these young adults will gain the Resilience to quickly recover from hard circumstances, the Independence to care for themselves without future assistance, the Success to accomplish their goals and the Empowerment to feel confident in taking control of their futures."

When Ellie* (name changed) reached out to Advocates' RISE Youth Housing Program, she was experiencing the dark trauma of her mom's death and the lack of local family support. She was in high school, attending classes and working while trying to continue living alone in her mother's home.

Her determination and perseverance allowed her to enter the Advocates housing program and obtain an apartment paid for by RISE. After finding stable housing, she graduated on time with honors and applied to multiple colleges in the area. While participating in RISE, Ellie maintained employment and worked hard toward obtaining scholarships for secondary education. She was accepted to Kennesaw State University and achieved her goal of being accepted to the CARES program that provides year-round housing for students in need.

When she exited the RISE program, she received six months of continued case management and shared her amazing successes. She is passing all of her classes, living in on-campus housing, joining the school's barbell team and running for senator of the college for construction and agriculture. Ellie has a bright future and is deeply grateful to the Advocates' RISE program for allowing her to achieve the ambitious goals she set for herself. Her life is transformed.
