Hundreds of children now have hope for the future thanks to the vision – and persistence - of Advocates for Children. What was once a dream of one campus for all programs became a beautiful reality with the ribbon-cutting of Newman House.

"The Newman House will come alive this spring when the drop-in center opens and will continue to blossom this summer when the children and youth move into the 14-suite home, complete with a large commercial kitchen, living areas,

kitchenettes in each room and the gift of love and guidance from a compassionate staff," said Rachel Castillo, Pres. and CEO of Advocates.

Leaders from Advocates and the community joined the Newman Family in breaking the barriers that have chained young people who have no home. In a symbolic act that brought tears to many in the crowd, the group cut a paper chain made by the children age 7-17 in the current Flowering Branch Children's Shelter who will now become part of the Newman House.



#### New race name honors Advocates' mission

#### **A HOMELESS TEENS**

Triumph

Logan's mother was fighting addiction and couldn't care for her daughter, so grand-parents stepped in. But they mistreated her and soon she was a homeless teenager.

Coping with great loss, Logan turned to couch-surfing and sleeping in cars. A referral to Advocates put her on the long road back to stability. It started with drop-in services like enrolling back in school and receiving her diploma, then progressed to receiving Medicaid and financial assistance.

"I walked to about 15 job interviews up and down Joe Frank Harris Parkway," she said of her determination to find employment. Eventually, she found work and later an even better job. She got her driver's license, was able to purchase a vehicle and found an apartment, all with the guidance and encouragement of Advocates case managers.

Her plan is to attend a trade school and maintain current housing. Life is very different now and she's found hope.

"Even after I completed the program at Advocates, I felt supported though bi-monthly case management. Without Advocates, I wouldn't be here."



### Cobb location moving to bigger program space

After just three years, the Advocates program in Cobb has outgrown its space and is moving from Kennesaw to a more central location in Marietta. The new offices will be on the bus line and near other nonprofits who network with Advocates to provide extended resources.

The Cobb location began with an emphasis on keeping families together who were involved with the child welfare system and living in poverty. The goal is to keep those families intact so children are not removed to foster care because of poverty issues that can be corrected. Family navigators

help determine needs such as food, clothing, employment, transportation and housing and work with the families to access resources.

"Most of our clients have nowhere to turn," said Family Navigator Kataya Brown. "They don't know what's available to them or how to access resources. We provide emergency relief through our food pantry and clothes closet, then begin to untangle their complicated situations by guiding them to viable solutions.

"These families usually come to us through DFCS or the school systems and are known to be loving parents or grandparents who can't make it financially and are terrified of losing their children because of a lack of resources," she explained.

The Cobb office has doubled its caseload with the addition of a second family navigator, plus a parent educator was recently added to provide in-home parent education.who was recently added. The team quickly becomes a stable source of hope for families living in despair. The office is also a designated Safe Place where runaway youth can find help and be referred to the Advocates program for unsheltered young people.

# April shines light on preventing child abuse



With Georgia ranking 38th for child well-being, Advocates focuses on raising awareness every April during Child Abuse Prevention Month. What is a year-round effort by the nonprofit comes to the forefront of the community during a month to alert others to the growing number of abused and neglected youths.

The activities kick off with a March 31 Bartow Courthouse planting of blue pinwheels, the national symbol for child abuse prevention. Pinwheels will also be planted at Harbin Clinic, an Advocates corporate partner, and on the Advocates campus at 827 Joe Frank Harris Parkway.

In addition, April 4 will be "Wear Blue Day" in the 11-county region Advocates served and supporters can buy a virtual pinwheel to be planted online in honor or memory of a child. Follow Advocates' social media for details. A round up campaign will allow local retailers to round up sales for an Advocates donation and the mayor will sign a proclamation in April.
