Advocates for Children Expands Cobb County Services with New Marietta Office

In an exciting step forward, Advocates for Children has expanded its footprint in Cobb County with a new, more centrally located office in Marietta. The launch was celebrated with a ribbon-cutting and open house, drawing enthusiastic support from community leaders, partners, and neighbors.

The new location houses a Family Resource Center, in-home parenting education services, and a Safe Place program for runaway and homeless youth. Relocating from Kennesaw to a larger space along a public transit line makes services more accessible to families who need them most.

This move also creates greater opportunities to collaborate with other service providers through Cobb Collaborative and strengthens partnerships with both the Marietta and Cobb County School Districts and the Cobb Department of Family & Children Services.

Several key funding partners have made this growth possible, including the Joseph B. Whitehead Foundation, Cobb EMC, Cobb Community Foundation, CaxMax, Publix Super Market Charities, Johnson Ferry Baptist Church, and Mt. Pisgah Seventh Day Adventist Church.

With this expansion, Advocates for Children strengthens its mission to ensure the safety, stability and wellbeing of children and families in the region. The organization looks forward to deepening its impact in Cobb County and continuing to be a trusted resource for children, youth and families in need.

As area leaders and community members arrived with gift cards, bedding, towels, games, and food, they were welcomed with a tour and staff-led explanations of the unique facility and life-changing programs.

"Our residents will be going on their annual beach summer vacation sponsored by Iron Order Motor Club and will return to discover the joys of living in a beautiful new 14-suite facility," said Rachel Castillo, President/CEO. "While they are gone, the Advocates staff will carefully move their personal belongings into their new suites. They'll return to homelike private bedrooms with full baths, microwaves, refrigerators, study areas, and closet space—all their own. This will be their home away from home."

The Outreach Center will open first, providing homeless and runaway youth with showers, meals, clothing, computer access, and a caseworker to help plan next steps. "Last year, 64 children and youth were diverted from homelessness," Rachel shared. "Newman House allows us to do even more."

Single Father finds support in building a stable home for his children

A difficult year-long journey has ended with stability for Diego and his two young children, thanks to the dedication of the Advocates Family Resource Center Team. This family's story is one of many that reflect the power of professional case management and compassionate community support.

In November 2023, Diego was referred by Department of Family & Children Services (DFCS) after his children's mother left. He was suddenly alone—caring for Elena (4), who has multiple disabilities, and Mateo (3)—while struggling to keep a job and pay mounting bills. With no childcare, limited English, and no support network, Diego faced eviction and the threat of losing his children to foster care.

Elena's needs felt overwhelming, and navigating systems alone proved nearly impossible. Unfortunately, 18% of Cobb County foster care cases last year were due to inadequate housing—often affecting families like Diego's, who fall through the cracks due to lack of resources for DFCS caseworkers. Advocates for Children is helping bridge that gap.

A letter from Diego

Hello my name is Diego, and I would like to introduce you to Elena and Mateo. We are a family that has benefited from Advocates for Children, and we are grateful for the support that has benefited us greatly. They have given us excellent attention, always responding to our needs in all aspects of support and I want to thank this institution because they have always been aware of us, calling us to ask about any needs we may have now. I am grateful to all the staff, hoping that they continue helping more families. Thank you, Kataya Brown and Advocates for Children!

When Program Manager Kataya Brown met Diego, the family was days from eviction. Advocates covered rent and utilities, giving him the breathing room to afford a babysitter and return to work. Over the next year, Kataya helped him access daycare, food, and financial aid, walking alongside him through each step of recovery.

Today, the family is thriving. The children are safe, smiling, and no longer at risk of foster care or homelessness. DFCS has closed the case, and while Diego occasionally visits for diapers, he no longer needs formal help.

What he needed most was a chance—and someone to believe in him. Now, he tucks his children in each night under a safe roof, grateful for the support that helped him keep his family together.

EXPANDING SAFE HAVENS:

Tackling Youth Homelessness in Northwest Georgia

Georgia faces a serious homeless youth crisis, with over 3,300 homeless and runaway youth each year and a state ranking of 37th in child well-being. In response, Advocates has expanded the Safe Place programming. Advocates operates in nine Northwest Georgia counties, working to make help easily accessible and raise awareness about the vulnerability of homeless youth.

Across our community, Safe Place sites are easily recognized by their yellow-and-black signs. These trusted locations—including Table on Delk, Hilton Inn, Churches, YMCA branches, and QuikTrip gas stations—serve as immediate entry points to safety for youth in crisis.

When a young person, ages 6 to 17, walks into a Safe Place site, they are quickly connected to a caring, trained adult who listens without judgment, ensures their immediate safety, and contacts our team at Advocates for Children. Our staff responds 24 hours a day, 7 days a week, providing transportation, a safe 21-day shelter, case management, and access to mental health services. Each situation is handled with compassion and care, with the goal of family reunification, stable housing, or other long-term solutions.
